Minutes of the Ordinary Parish Council meeting held On Wednesday 5th March 2025 at 7pm in St John's Church

1. To record the names of those present

2. To consider accepting apologies for absence

It was **resolved** to accept apologies from Cllr M Knights.

3. To consider co-option applications

There were no applications for co-option to consider.

5. To approve the minutes of the last ordinary council meeting held Wednesday 5th February 2025

It was resolved to approve the minutes of the meeting held 5th February 2025 as a true and accurate record. The minutes were duly signed by the Chair.

6. To allow public participation – to include information from developers, Police representatives, or any other person invited to speak

The parishioners present noted that there is still a 70mph speed limit on the old A47. They feel that the traffic is too fast to walk along especially with a buggy. Noted that an accident happened last year. The road is a mile long and it is being used as a drag strip. They feel that the end of the dual is a heavy breaking area and would like the speed dropped. Would like the speed reduced from 70mph but not sure what the speed limit should go down to. Both ends of the stretch of road are currently 30mph. Noted that the recommendation in the feasibility study would be to make is a single carriageway.

7. To receive reports from Borough and/or County Councillors

Cllr Kunes – discussed the Norfolk & Suffolk devolution. 2026 will be the election for a mayor. Borough will have elections for shadow elections. Cllr Kunes discussed the devolution.

Planning is an issue with the current government and there is pressure on them to accept more applications. There is a target of 550 builds in the borough in the year. If they are below target, then there be an action imposed. However, the target number has been increased to build 1000 homes in the borough. There are some big projects happing in the borough but there will be pressure on them to accept more.

The ferry at West Lynn has been suspended as the steps need to be repaired. This is a NCC responsibility.

Councillors briefly discussed village hall matters and going forward.
